### 5. Important Information About Registration Cancellation

Registration may be cancelled only until March 15, 2020. In such cases, Other Music Academy e.V. will refund the fee paid minus 100,- €. Cancellations after that date will not receive a refund, UNLESS the person who cancels is able to find another person to register in their place.

In order for the workshops to take place, a minimum number of registrations must be received by March 15, 2020. If the minimum number is not reached, Other Music Academy e.V. reserves the right to cancel the work-

shop. In such a case, the entire registration fee will be refunded. So please register early to help ensure that the workshops take place and to help us plan. Thank you!
